- a) 15/02/17 e-mail regarding Public Space Protection Order Consultation The proposed PSPO is to replace previous legislation to enable WLDC to take action against those who do not pick up after their dog. It will allow use of fixed penalty notices or prosecution where fouling is not picked up, or where the picked up fouling is not properly disposed of. The PSPO will apply to all land in West Lindsey which is open to the air, and to which the public have a right or entitlement of access; this includes council land, highways and land such as Churchyards or public rights of way. Consultation closes 27/03/17 review of proposal (e-mailed prior to the meeting) and feedback requested for the consultation so that the questionnaire can be completed.
